

Terms & Conditions of engagement against above temporary positions :-

1. The engagement for RA and SRF will be initially up to March, 2023 to till further orders. However, it is extendable upto five (05) years or till the date of termination of project, whichever is earlier. The appointment is purely temporary and co-terminus with the duration of the project subject to satisfactory performance.
2. Engagement of YP-II will be initially for 1-year, extendible for two more years (1+1+1 yrs).
3. The crucial date for determining the age limit shall be the date of Interview.
4. **The walk-in-interview for the position at Sl.No. 1 to 4 will be held at Research Centre, Sunabeda, Distt. Koraput, Odisha and for Sl.No.5 at ICAR-IISWC, 218-Kaulagarh Road, Dehradun, Uttarakhand.**
5. For the positions at **Sl.No.1 to 4**, the **selected candidates'** will be initially posted at **RC-Koraput**. However, he/she can be posted any where preferably within Odisha State as per the requirement of the Project without any extra payment except emoluments.
6. For the position at **Sl.No. 5** the selected candidate will be posted initially at **Dehradun**. However, he/she can be posted anywhere as per the requirement of the Project without any extra payment except emoluments.
7. The positions are purely time bound, temporary on co-terminus basis with the Project and do not entitle the appointment to any claim implicit or explicit on any ICAR post.
8. The essential qualification given in the advertisement against each position is minimum. Candidates possessing higher qualification in the relevant fields may also be considered for these positions subject to their suitability of the position.
