TERMS & CONDITIONS

- 1. Bid should be submitted in sealed cover super scribed bid for the disposal of Unserviceable/condemned store items due on 25.02.2021 and the quotation should be addressed to the Head, ICAR: Indian Institute of Soil & Water Conservation Research Centre, Sector 27-A, Madhya Marg, Chandigarh-160019 and deliver in person or by registered post so as to reach in the office on or before 25.02.2021 upto 1.00 P.M. positively. This office shall not be responsible for any delay in postal transit. No bid shall be accepted after the due date and time. If the due date is declared as government holiday the bid due date will be next working day at the same time notified as above.
- Bid should be signed by bidder(s) himself/themselves or a person duly authorized on his behalf. A copy of such authority letter should be enclosed along with the offer.
- 3. Bid forms are not transferable.
- 4. Bid will be opened on the same day i.e. 25.02.2021 at 02.30 P.M (Sharp). If the date of opening of bids happen to be a holiday, then the bids shall be opened on the next working day of the same time.
- 5. Bidder(s) can inspect the store items between 09.30 A.M. to 4.00 P.M. from 08.02.2021 onward at ICAR- Indian Institute of Soil & Water Conservation Research Farm, Mansa Devi, Panchkula, Haryana. In regard to the conditions, quality etc of items and satisfy themselves before submitting their offer by the date and time specified. No other day fixed for inspection of stores items.
- Overwriting or alteration will also disqualify the bids unless these are legible attested by bidder/bidders.
- Rates should be kept valid for acceptance at least 180 days from the date of opening.
- 8. The Sales-tax and other levy if any; will have to be paid by the successful bidder.
- 9. Each bid should be accompanied by an earnest money of Rs.5000/- (Rupees five thousand only) drawn in favor of the Head, ICAR-IISWC RC, Chandigarh in the shape of POS machine/Demand Draft/Pay Order/RTGS/NEFT/BT payable at Chandigarh The bidders are advised to quote the bid amount in lump sum for the whole items under auction. The rate should be quote in both figures as well as words. The incomplete quotation is liable to be rejected.

- 10. It will be presumed that the bidders before submitting the offer have read carefully all the terms and conditions and accepted the same full, deviations from the terms and conditions as given in this are not permitted. Any such conditional bid and/or telegraphic bid is liable to be rejected and no alternations shall be allowed after the bid is submitted. No counter terms and conditions shall be accepted.
- 11. Right to include any other conditions, notify, or alter any of the quotation conditions already stipulated is reserved by the Head, ICAR: Indian Institute of Soil & Water Conservation, Research Centre, Sector 27-A, Madhya Marg, Chandigarh-160019.

12. Payment and deliveries:

- (a) The successful bidder will be required to make full payment of bid to be deposited in the form of Pay Order/DD/RTGS in favour of Head, ICAR: Indian Institute of Soil & Water Conservation Research Centre, Sector 27-A, Madhya Marg, Chandigarh-160019. Within 7 days of issue of acceptance order and complete lifting of unserviceable/Condemned items within 15 days. Thereafter earnest money deposit shall be forfeited.
- (b) The successful bidder will have to lift the unserviceable/Condemned items within 15 days after depositing the full amount of payment, as per terms and conditions of the bid. Deliveries shall be affected against receipt of payment. Any purchaser failing to lift the material within the above stipulated period shall have to pay ground rent @ Rs.500/- per week. The Institute will not be responsible for any loss or damage of the unserviceable/condemned items.
- (c) Earnest money deposited shall be forfeited if any purchaser fails to lift the items after making full payment and expire of period as mentioned above. Thereafter Head, ICAR-IISWC RC, Chandigarh shall be entitled to resell the items. No notice shall be issued to the bidder in this regard.
- 13. The purchaser will not be entitled to resell any of all unserviceable/Condemned items while they are still lying within the premises of Research Farm, Mansa Devi.
- 14. Loading, handling, labour and transportation shall have to done by the purchaser at his own cost, risk and arrangement.
- 15. Loading and lifting should be done by the purchaser only during the working hours. No delivery shall be allowed on Sunday and holiday.
