

On the behalf of the Secretary, ICAR, New Delhi, the Director, ICAR-IISWC, Dehradun invites Limited Tender/Quotations in two bid systems (Technical & Financial Bid) for "Installation of HDPE pipeline systems at Jar Gaon village, Satyon (Tehri Garwal) under SCSP Plan as per following descriptions :-

In case your firm is in a position to execute the above work, kindly send your bid in two bid systems. The first sealed envelope shall contain Technical Bid and second sealed envelope financial bid. Both these envelope shall be be further kept in single sealed cover envelope superscribing as "Limited Quotation for Installation of HDPE pipeline systems at Jar Gaon village, Satyon (Tehri Garwal) under SCSP Plan".

The details of documents to be kept in technical and financial bid envelope is as under:-

1. Technical Bid Envelop

The firm shall submit its technical bid in separate sealed envelope superscribing as "Technical Bid Envelope" wherein the following documents shall be kept to be declared as responsive bidder failing which quotation shall be treated as un-responsive and rejected:

- i. A copy of complete set of Limited Tender Enquiry document sent to the firm affixing firm's seal and signature of authorized person on each page to evident and certify all terms & conditions and requisite certificates. In case this document is not attached with the quotation, the quotation will be rejected.
- ii. Original FDR, Bank Guarantee or Demand Draft of Earnest Money Deposit of **Rs.8,000/-** (Rupees eiight thousand) only in favour of "**ICAR (Unit) IISWC**" payable at Dehradun.
- iii. A copy of PAN Card and GST registration of the firm. (Mandatory document).
- iv. Registration of firm with appropriate agency for execution of any branch of civil work under contract. (**Mandatory document**).
- v. In case of NSIC/MSME registered firm for above supply, the requisite certificate alongwith Bid Security declaration as at annexure II is to be submitted by respective firm for claiming EMD exemption.
- vi. A certificate to the effect that that the firm has not been blacklisted/debarred by any government organization/undertakings and no legal/criminal suit is pending or contemplated against it. (**Mandatory document**).
- vii. ITR for the last 03 financial years (2017-18, 2018-19 & 2019-20)
- viii. Copies of work orders, <u>if any</u> showing the construction work under contract executed by firm for government departments/undertaking during last three years in support of terms & condition **No.4.**

The price bid of only responsive bidders shall be opened.

2. Financial Bid Envelope

The firm shall submit its financial bid in separate sealed cover superscribing as "Financial Bid Envelope" in the prescribed format in <u>Annexure-I</u> in firm's letter head showing registration of firm, GST No., terms & condition of worky, warranty period etc.

The last date and time for receipt of quotation is 26.02.2021 till 2.00 p.m.. The Technical Bid of the bidders shall be opened on the same day i.e. on 26.02.2021 at 3.00 p.m. in Dr. J.S. Bali Committee Room of the Institute. The limited quotations received after last date and time i.e. 26.02.2021 till 2.00 p.m. shall not be accepted/entertained. After evaluation of technical bid, the date of opening of financial bid shall be communicated to the responsive firms in due course of time.

Terms & conditions of the Limited Tender Enquiry is as under :-

1. The firm shall be responsible for **Installation of HDPE pipeline systems at Jar Gaon village**, **Satyon (Tehri Garwal) under SCSP Plan** at Village **Jar Gaon village**, Tehri Garhwal.

- 2. The firm shall have to arrange material required for **HDPE pipeline systems** at its own as per description & Specification stated above.
- 3. The firm shall execute the work under the contract under the supervision of Institute's nominated officer.
- 4. The criteria for selection of successful bidder shall be (i) the responsive bidder and thereafter (ii) Lowest Price Bid (L-1 rates) quoted by the firm for the work meeting requisite specifications. In case, L-1 rate of a item of more than one firm is same then the firm having maximum turn-over during last three years in government department/ undertakings shall be given preference for deciding L-1 bidder. So while sending quotations, the firm should also submit documents to evident work executed by the firm in government departments/undertakings to evaluate the quotation.
- 5. The Firm shall ensure that quotation is properly sealed and prepared so as to prevent any subsequent alteration and replacement. All terms & conditions of the contract should be clearly spelt out in the quotation.
- 6. The firm may deposit/attach demand draft of Rs.8,000/- (Rupees eight thousand) only towards Earnest Money Deposit (EMD) in favour of "ICAR (Unit) IISWC" payable at Dehradun alongwith its technical bid. Firm registered with NSIC/MSME will be exempted for deposition of EMD but they will have to submit its registration certificate. In case successful firm fails to accept/execute the work, EMD shall be forfeited. No interest shall be paid on the EMD. The EMD shall be refunded after deposition of performance security deposit. No interest shall be paid on the EMD. The EMD shall be refunded after deposition of performance security deposit. Bid Security declaration form should be submitted by the MSME/NSIC. Annexure II
- 7. The work executed by the firm alongwith used material shall be kept under observation for a period of <u>six months</u>. Hence, 03% Performance Security Deposit of the quoted rate shall be deposited by the successful firm. This Performance Security shall be refunded to the firm after <u>six months + 30 days</u> from the date of work completion report on the demand raised by the contractor.
- 8. No interest on EMD and Performance Security Deposit shall be given.
- 9. The validity of quotation should be **90** days from the date of opening of tender.
- 10. Complete details and ISI specification of the material to be used in work under contract, <u>if any</u> must accompany with the quotation.
- 11. Catalogue of the material, <u>if any</u> of requisite goods required for work under contract should be attached with the quotation.
- 12. The material to be used in work under contract will be subject to inspection and approval before execution of work.
- 14. Manufacturers/supplier warranty certificates and manufacturer/government approved lab test certificate for the items used, <u>if any</u> should also be furnished alongwith quotation.
- 15. Quotation should be clearly filled in by blue ink pen. This should be free from any correction/erasure. In case there is any unavoidable correction, it should be properly attested by the firm, if it is not done, it will not be considered.
- 16. The Director, ICAR-IISWC reserves right to accept or reject any or all quotations without assigning any reason thereof and does not bind itself to accept the lowest quotation.
- 17. Participation in this tender is by invitation only and is limited to the firms to whom Limited Tender Enquiry has been sent.
- 18. The Limited Tender Enquiry is also being uploaded/published on Institute Website and CPP Portal. The quotations received against advertisement on Institute website/CPP portal shall also be considered for evaluation in tender process.
- 19. Name of the manufacture and country of origin of goods offered must be clearly specified in the quotation.
- 20. Terms of delivery/execution of work :- At Village Jar Gaon, Tehri Garhwal, Uttarakhand.
- 21. Execution of work (execution of work, testing and commission):- within 30 days from the date of issue of work order.
- 22. Terms of inspection of material/work :- By the purchaser's authorized representative.
- 23. Once offer of an firm is accepted, the prices quoted should be firm till the work is executed.
- 24. Price structure:-

- a) The firm may submit its **Price Bid** in the prescribed format as per **Annexure-I**.
- b) The rates and prices quoted shall be in Indian Rupees only.
- c) In case GST is not shown separately, the quotation shall be rejected.
- 25. <u>Terms of payment</u>: Payment of goods will be release after successful/satisfactory completion of work within the prescribed period and verification of quality and quality etc. by the indenter.
- 26. <u>Warranty Clause</u>: Warranty of goods to be used in construction work should be clearly indicated in quotation.
- 27. <u>Dispute Resolution Mechanism</u>: If any dispute or difference arises between the purchaser and the supplier relating to any matter connected with the supply/work, the parties shall make every effort to resolve the same amicably by mutual discussions. However, If the parties fail to resolve the dispute or difference by such mutual discussion within 30 days, either the purchaser or the supplier may give notice to the other party of its intention to refer the same to arbitration. The arbitration shall commence thereafter as per prescribed rules/guidelines of Arbitration.
- 28. Any dispute is subject to the jurisdiction of the Court at Dehradun .
- 29. **Liquidated Damage Clause: -** In case firm's quotation is accepted and order is placed, the work against the order should be made/executed within 30 days failing which a sum equivalent to ½ % (half percent) of the total value of the item covered in the order will be imposed as Liquidity Damage on per day basis subject to a maximum of 5% (five percent) unless extension is obtained in writing from the office on valid ground before expiry of delivery period. Thereafter the work orders automatically deemed to be cancelled with forfeiture of EMD deposited by the firm.
