Quotation should be submitted in sealed envelope addressed to the Director, ICAR – IISWC, 218, Kaulagarh Road, Dehradun -248195 (Uttarakhand) super-scribed with the words "Providing & Fixing overhead storage in room no. 313 at Instt HQ Dehradun" on the outer cover of the envelope by Speed Post/ Registered Post or dropped in quotation box kept in works section of Institute HQ latest by 03.03.2021 upto 15:00 hrs at the address given above. The quotations will be opened on the same day at 15:30 hrs where you or your representative may be present, failing which, it will be opened in your/his absence. Terms and Condition:

- 1. An earnest money of **requisite amount ie Rs. 2600/- (Rupees Two thousand six hundred)only** must be deposited in the form of *demand draft/TDR/Bank Guaranty* in favour of "ICAR (Unit) CSWCRTI, Dehradun" payable at Dehradun has to be deposited with the quotation *failing which the bid may be rejected*.
- 2. The contractor will quote the rates on his letter Pad. Licence /registration issued by State Govt may be enclosed.
- 3. The EMD of unsuccessful bidder shall be returned only after the completion of codal formalities on receipt of written request. In case the successful bidder does not accept the offer, the EMD shall be forfeited. No interest on EMD shall be paid by the Institute.
- 4. **GST** registration certificate and **PAN** has to be enclosed with the bid.

- 5. **Performance Security Deposit of 5% of the total amount** of work order is to be deposited by the successful bidder to whom contract is awarded. The Performance Security Deposit is to be deposited only after receiving a communication from the IISWC. In the event of non-deposition of the same, the earnest money may be forfeited and contract shall be cancelled. The performance security shall be returned to the firm after completion of contract period (including extendable period, if any) + 6 month and no interest on Performance Security shall be paid by the IISWC
- 6. You may contact Incharge (Works) for any clarification regarding the work.
- 7. The payment may be made after completion of work satisfactorily and submission of prereceipted bill after deduction of taxes as per Govt. Norms.
- 8. Each bidder should submit only one bid for this tender.
- 9. The firm to whom contract may be finally awarded shall not transfer or sub-let the contract to other firm.
- 10. If a tenderer does not accept the offer, after issue of letter of award by IISWC within 10(Ten) days, the offer made shall be deemed to be withdrawn without any notice & earnest money shall be forfeited.
- 11. GST or any other tax applicable or made applicable after awarding the contract in respect of this contract shall be payable by contractor and IISWC will not entertain any claim whatsoever in this respect. However, the income tax or any other tax which is as per the rules of the Govt. of India shall be deducted at source from the final bill of the successful tenderer, as per rules/instructions made applicable from time to time by government.
- 12. Decision of the Director, IISWC shall be final for any aspect of the contract and binding to all parties. Disputes arising, if any, on the contract may be settled at his level by mutual consultation and in case of failure in settlement dispute shall be referred to the sole arbitrator to be appointed by the Director, ICAR-IISWC. The decision of the sole arbitrator so appointed shall be final and binding on the parties. Arbitration proceeding shall be governed by the Arbitration & Conciliation Act, 1996 as amended from time to time.
- 13. Institute does not pledge itself to accept the lowest or any other tenders and also reserve to itself the right of accepting the tenders whole or in part keeping in view valid reasons. Conditional tenders will not be accepted.
- 14. Successful Bidder/tenderer will have to enter into a detailed contract agreement with IISWC on non-judicial stamp paper of Rs. 100/- (One hundred only) for work as per the specimen attached with the tender document.
- 15. The Contractor must employ adult labour only. Employment of child labour may lead to the termination of the Contract.
- 16. The contractor must follow C.P.W.D. safety code while executing the work. Whole responsibility may be of contractor for any lack in safety in respect of the labour employed or structure under construction / repair.
- 17. The contract is subject to the condition that the tenderer will comply with all the laws and acts of Central Govt., State Govt. relating to this contract made applicable from time to time.
- 18. Any misconduct/misbehaviour on the part of the manpower deployed by the agency will not be tolerated and such persons will have to be replaced immediately.
- 19. Work should be completed within **21 days** after issue of work order.
