

Terms and Conditions:

1. The validity of quotation /bid should be 90 days from the date of opening of quotation/bid.
2. The awarded firm/ party should ensure for watch & ward, application of basal dose, weeding cutting, transportation, threshing, bagging of the produce harvested from specified area only.
3. The awarded firm should allow the Scientist, Technical Officer, Technicians, I/c F Farm Supdt. during their visit to the area for collecting data etc.
4. The rates should be quoted for the entire but specified area of the irrigated Maize crop only.
5. The fieldworks to be carried out as per normal practice and the area should be maintained properly by cleaning etc. All other instructions will be given by the I/c F Farm Supdt. OIC(Farm) from time to time for better maintenance of the crop area.
6. The surrounding area(s) should be well maintained by scraping weeds and the debris/slashes should be removed from the area(s). All the inputs including fertilizer, pesticides are to be arranged at your own cost as per normal practice. Prior approval may be taken from the OIC (Farm) for arranging necessary advice and supervision.
7. If any disease is observed, the same should be reported to the OIC (Farm)/Farm Supdt. Necessary protection measures should be taken and protected under the guidance of Scientists/ OIC (Farm) /Farm Supdt. of the Centre.
8. The weeding, harvesting of crops, threshing and its transport to be done by the successful bidder and labourers have to be arranged by him at his own cost. Harvesting of crops will have to be done between 10.00 A.M. to 5.00 P.M. on working days only and transportation should made through Research Farm main gate only.
9. The successful bidder will be allowed on his request to utilize the farm field bund area where the specified crop is being cultivated.
10. The crop area and its surroundings may be maintained neat and clean which may serve demonstration value to the farming community.
11. Inputs data and harvested produce details are to be maintained in a register and should be made available to the Research Centre on quarterly basis for Research analysis and publication purpose.
12. The Research Centre or Institute is not responsible for any kind of incidents including loss of life. It is sole responsibility of the bidder to bear the loss on paying compensation to the workers in case of any accident, loss of life etc.
13. The crop area, other experimental plots/area(s) and other crop area(s) should not be damaged and if any damage is observed, the cost will be recovered from the successful bidder at the discretion of the undersigned. Cutting and carrying of any firewood and grasses are strictly prohibited.

14. Quotation/bid should be sent in a sealed cover addressed to the undersigned duly super scribed "Tender for Standing Crop Auction-Kharif Maize (Irrigated) 2022-23".
15. The rate may be quoted after inspecting the areas. The inspection may please be done during the working hours from 10.00 A.M. to 5.00 P.M. The OIC (Farm)/l/c. Farm Supdt may please be contacted for further information.
16. The last date for receipt of Quotations/bids at this Centre is 22.08.2022 at 3.00pm. The quotations/bid will be opened at 3.00 P.M. on the same day. The bidders or his representative can be present at the time of opening the quotations. If the highest bid quoted is not satisfactory, the Competent Authority reserves right to auction among the bidders who have submitted tender or re-auction or cancel the auction.
17. E.M.D. of Rs.2,000/- (Rupees Two Thousand only) through POS/ Demand Draft favouring "Head of the Centre, ICAR-IISWC payable at SBI, Ballari or any kind of e-payment and proof of deposit should accompany the bid which will be refunded to the unsuccessful bidder except the successful bidder.
18. This centre will not allow/entertain the participants who have not deposited the EMD.
19. The party/ person deposited the EMD is only allowed in the bid process.
20. The undersigned reserves the right to accept or reject the auction without assigning any reason. The successful bidder should deposit 25% of the quoted amount as advance on the next day and balance 75% shall be remitted within 15 days. The bidder will be allowed to harvest only on receipt of 100% of total value quoted.
