Terms and Condition:

- 1) **The sealed quotations will be considered from registered contractors.**
- 2) An earnest money of **requisite amount i.e. Rs. 8,000/- (Rupees eight thousand only)** must be deposited in the form of **demand draft/FDR** in favour of **“ICAR (Unit) CSWCRTI, Chandigarh”** payable at Chandigarh to be deposited with the quotation ***failing which the bid will be rejected.***
- 3) The contractor will quote the rates on his letter Pad, ***failing which the bid will be rejected.***
- 4) The EMD of unsuccessful bidder shall be returned only after the completion of codal formalities on receipt of written request.
- 5) In case the successful bidder does not accept the offer, the EMD shall be forfeited. No interest on EMD shall be paid by the Institute.
- 6) **GST** registration certificate and **PAN** has to be enclosed with the bid.
- 7) Certificate indicating that the **firm/contractor is registered with CPWD/PWD.**
- 8) **Performance Security Deposit of 10% of the total amount of work order is to be deposited by the successful bidder to whom contract is awarded within 10 days.** The Performance Security Deposit is to be deposited only after receiving a communication from the IISWC. In the event of non-deposition of the same, the earnest money will be forfeited and contract shall be cancelled. The performance security shall be returned to the firm after completion of contract period (including extendable period, if any) + one year and no interest on Performance Security shall be paid by the IISWC.
- 9) You may contact Head of Centre for any clarification regarding the work.
- 10) The payment will be made after completion of work satisfactorily and submission of pre- receipted bill after deduction of taxes as per Govt. norms.

- 11) The deduction of necessary Taxes as applicable will be made from the bill of the contractor
- 12) Each bidder should submit only one bid for this tender.
- 13) The firm to whom contract will be finally awarded shall not transfer or sub-let the contract to other firm.
- 14) If a tenderer does not accept the offer, after issue of letter of award by IISWC within 10 (Ten) days, the offer made shall be deemed to be withdrawn without any notice & earnest money shall be forfeited.
- 15) GST or any other tax applicable or made applicable after awarding the contract in respect of this contract shall be payable by contractor and IISWC will not entertain any claim whatsoever in this respect. However, the income tax or any other tax which is as per the rules of the Govt. of India shall be deducted at source from the final bill of the successful tenderer, as per rules/ instructions made applicable from time to time by government.
- 16) Decision of the Head, IISWC Research Centre, Chandigarh shall be final for any aspect of the contract and binding to all parties. Disputes arising, if any, on the contract will be settled at his level by mutual consultation and in case of failure in settlement dispute shall be referred to the sole arbitrator to be appointed by the Head, ICAR-IISWC. The decision of the sole arbitrator so appointed shall be final and binding on the parties. Arbitration proceeding shall be governed by the Arbitration & Conciliation Act, 1996 as amended from time to time.
- 17) Institute does not pledge itself to accept the lowest or any other tenders and also reserve to itself the right of accepting the tenders whole or in part keeping in view valid reasons. Conditional tenders will not be accepted.
- 18) The Contractor must employ adult labour only. Employment of child labour may lead to the termination of the Contract.
- 19) The contract is subject to the condition that the tenderer will comply with all the laws and acts of Central Govt., State Govt. relating to this contract made applicable from time to time.
- 20) The Institute will not be responsible for untoward incidence.
- 21) The contractor/Agency shall be responsible for all injury/accident, if any, to person(s) employed by him while on duty.
- 22) The tenderer should not have been blacklisted from any government department/ undertaking. An undertaking to this effect should be enclosed with the bid.
- 23) Work should be completed within 45 days of acceptance of contract.

Liquidated damages clause:

- i. If the contractor fails to deliver the job or perform the work within the time period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to 1% (one percent) of the total amount of the work order towards the delayed work for each month of delay or part thereof until actual delivery or performance up to a maximum deduction of 10%(ten percent) of the delayed work contract price.
- ii. Any misconduct/misbehaviour on the part of the manpower deployed by the agency will not be tolerated and such persons will have to be replaced immediately.
