Terms and conditions:-

- The registration of the bidders will be done on 02.10.2024 (3.00 Pm to 4.30 Pm) and auction will be done on 03.10.2024 at 10.00 Am hours onwards. The interested bidders may visit Centre from 02.10.2024 to 03.10.2024 along with documents to take part in auction on 03.10.2024.
- The inspection of the Chilli Variety (sygenta 5531) will be allowed between 10.00 AM to 05:00 PM on all working days with prior approval of the Head, RC, Ballari.
- Interested bidders may participate in the open auction and may quote their lump sum rate for entire Chilli Variety (sygenta 5531) 3.5 Ac after depositing an registration fees of Rs.5,000=00 in the form of demand draft drawn in favour of "Central Soil and Water Conservation" payable at State Bank of India, Ballari or any kind of e-payment (Centre's current A/c No.: 10768619218 and IFSC code: SBIN0000817) or Cash Deposit on the day of auctioning and proof of deposit must be submitted which will be refunded to the unsuccessful bidder except the successful bidder after completion of the auction.
- The bidder who wants to participate should submit the pre requisite documents viz. Aadhaar, PAN, Address Proof, Bank Account details, GST (if available) and Acceptance Letter of the terms and conditions laid down in the auction notice.
