- 3. The awarded firm should allow the Scientist, Technical Officer, Technicians, I/c.Farm Supdt. during their visit to the area for collecting data etc.
- 4. The rates should be quoted for the crops specified for this particular season crops only.
- 5. The surrounding area(s) should be well maintained by scraping weeds and the debris should be removed from the area(s).
- If any disease is observed, the same should be reported to the OIC (Farm)/Farm Supdt.
  Necessary protection measures should be taken and protected under the guidance of
  Scientists / OIC (Farm) / Farm Supdt. of the Centre.
- 7. The harvesting of crops, threshing and its transport to be done by the successful bidder and labourers have to be arranged by him at his own cost. Harvesting of crops will have to be done between 10.00 A.M. to 5.00 P.M. on working days only and transportation should made through main gate only.
- 8. The crop area and its surroundings may be left neat and clean after harvesting.
- Harvest produce details are to maintained in a register and should be made available to the Research Centre for Research analysis and publication purpose.
- 10. The Research Centre or Institute is not responsible for any kind of incidents including loss of life. It is sole responsibility of the bidder to bear the loss on paying compensation to the workers in case of any accident, loss of death etc.
- 11. The crop area and other experimental and other crop area(s) should not be damaged and if any damage is observed, the cost will be recovered from the successful bidder at the discretion of the undersigned. Cutting and carrying of any firewood and grasses are strictly prohibited.
- 12. Quotation/bid should be sent in sealed cover addressed to the undersigned duly super scribed "Tender for Standing Crop auction".
- 13. The rate may be quoted after inspecting the areas. The inspection may please be done during the working hours from 10.00 A.M. to 5.00 P.M. The OIC (Farm)/I/c. Farm Supdt. may please be contacted for further information.
- 14. The last date for receipt of bid at this Centre is 13/11/2025 upto 3.00pm. The quotations/bid will be opened at 3.30 P.M. on the same day. The bidders or his representative can be present at the time of opening the quotations. If the highest bid quoted is not satisfactory, the Competent Authority reserves right to auction among the bidders who have submitted tender or re-auction or cancel the auction.

- 15. E.M.D. of Rs.5,000/- (Rupees Five Thousand only) through POS / Demand Draft favoring "Head of the Centre, ICAR-IISWC payable at SBI, Sunabeda should accompany the bid which will be refunded to the unsuccessful bidder except the successful bidder.
- 16. This centre will not allow the participants who have not deposited the EMD.
- 17. The party / person deposited the EMD is only allowed in the bid process.
- 18. The undersigned reserves the right to accept or reject the auction without assigning any reason. The successful bidder should deposit 100% of the approved amount within a period of 7 (Seven) days. The bidder will be allowed to harvest only on receipt of 100% of total value approved.
